

Profile Marc King, Ph.D.



In his 28 years of trial psychology work, Dr. King has gained incomparable experience consulting and advising on mass action litigation, complex civil cases, and the single "must-win" case.

Dr. King brings a combination of academic expertise, diverse litigation experience, and emotional maturity to every engagement. He has a unique perspective because he advises on both sides of the bar. This allows him to think like the other side.

Dr. King specializes in high conflict–high stakes cases in which the litigants are family or akin to family, meaning they are both financially and emotionally entangled, and the legal dispute is complicated by feelings of bitterness, vindictive anger, and betraval. These cases may involve: the dissolution of a long-

standing business partnership, siblings fighting over ownership of the family business, a contentious divorce in which corporate assets must be divided, a CEO accused of sexual harassment by a trusted employee, and other cases driven by emotionally charged, entrenched animosity.

Presenting the Strongest Case

While he is often asked to help with each phase of trial preparation, Dr. King consults on distinct aspects such as case strategy, theme development, crafting the case story, conducting pre-trial research using scientificbased methods such as the Confidential Trial Protocol®, helping prepare important witnesses for video deposition and trial testimony utilizing the Witness Effectiveness Protocol®, assisting with opening and closing statements, preparing voir dire questions for jury selection in federal and state courts, and providing trial attorneys with real-time counsel on what to ask and who to strike.

Dr. King has designed and managed integrated trial psychology research programs to assist trial attorneys prepare for multi-billion-dollar mass action litigation. With the ever-evolving challenges of multicultural dynamics and the impact of highly divided politics, Dr. King has the experience, judgment, and sensitivity to help the trial attorneys present their core case message persuasively to fact finders.

Witness Preparation

Dr. King developed the Witness Effectiveness Protocol®, a method proven to assist attorneys in preparing a critical witness, from assault victim to powerful CEO, to gain the confidence and skill to give truthful testimony maintaining the same credible demeanor whether on direct or hostile cross-examination. This is accomplished in secure online sessions (or in-person) with the witness and their attorney.

Experience Highlights Serving Defense

Supervising Trial Psychologist assisting a global pharmaceutical company, reporting directly to the General Counsel from 2000 through 2006. Before engaging Dr. King and his team, the company had lost multiple millions of dollars in the first five cases and faced 65,000 other individual cases. Dr. King developed and managed a fully integrated research program to revamp the defense. He guided and participated in all elements of pre-trial preparation and trial strategy execution.

Result: With Dr. King's strategic insight, the company began to win in venues around the country. More than 50 cases went to trial in Philadelphia during a two-year period. The defense won 86% of the trials, with either take-nothing or minimal damages verdicts.

Lead Trial Psychologist assisting a global consumer products company, reporting to the Associate General Counsel. Key responsibilities included discovering weaknesses with the defense trial case and quickly identifying corrective actions.

Result: Before Dr. King was added to the defense team, the first 13 trials were lost. After Dr. King provided real-time insight and guidance to the trial teams, they won the subsequent 8 cases.
